## Biennial Convention Delegate Election Notice

The 2007 OCSEA/AFSCME Local 11 27th Biennial Convention will be held at the Columbus Convention Center Aug. 23-25. This year's convention theme is "A New Partner, A New Beginning."

Pursuant to Article IX, Section 1(C) of the OCSEA constitution, the official delegate count for chapters will be determined on June 22.

Each chapter is entitled to send their president as a delegate plus one at-large delegate and alternate to be elected by the body membership. Additionally, chapters are entitled to elect one additional delegate and alternate for each 100 members in their chapter.

District Council and Assembly presidents are also delegates-at-large to the convention, as are members of the Board of Directors.

To be a delegate or an alternate you must have been an OCSEA member for at least two years.

As always, chapters are required to hold elections to elect their delegates. Chapters must provide by mail a written election notice to all members 15 days prior to the event. Members must present photo ID to vote. For the chapters below, this magazine listing constitutes their 15-day meeting notice.
